### Seymour Sinclair Investments Ltd Data Protection – Privacy Notice

### Introduction

We recognise our responsibility to treat your personal information with care and to comply with all relevant legislation, in particular the Data Protection Act 2018 and the EU General Data Protection Regulation (GDPR) which we refer to as the "legislation" in this document. This notice covers our requirement to provide you with information on how and why we use your personal data and of your rights under the legislation.

## **Data Controller**

We have provided you with a facility to make investments directly with fund managers or manage investments through platforms operated by Aegon and FundsNetwork. As a consequence of this activity we are classed as the "data controller" which means we process your data. The contact details are shown at the foot of this notice. Your personal data which is limited to the details provided on the application and subsequent investment data provided by the fund managers or the platform. The data is passed to these organisations who may be data controllers in their own right and may issue you with their own Data Protection Privacy Notices.

# **Personal Information**

We will not sell or rent your personal details to anyone

We will use personal information about you mainly to: -

- Provide you a low-cost facility to trade, switch or withdraw funds from your selected investments.

- Arrange and administer your investments
- Inform you about our products and services;
- Ensure appropriate preventative Money Laundering processes are implemented.
- Statistical analysis.

Some of the personal information we ask you to provide may be regarded as being sensitive as defined in the legislation, e.g. you may have to give us information about your occupation or place of birth. This information is required to support applications made to our platform providers without which the application cannot be completed.

If you give us information about another person, in doing so you confirm that they have given you permission to provide it to us and that we may use their personal data in the same way as your own as set out in this notice.

## Legal Basis for processing your Personal Information

We are required to have a lawful basis (as defined in the legislation) to process your personal data and the relevant bases which we use are show in the table below.

Purpose of processing	Lawful Basis
Providing investment facilities on an execution only basis allowing investments into funds via platforms or directly with the fund manager	Necessary for the performance of an investment contract.
Provision of information on products and services (Marketing).	Our legitimate interests or your explicit consent.
To notify you of changes in our service.	Our Legal and Regulatory obligations.
To prevent and detect fraud, money laundering and other financial crimes.	Our Legal and Regulatory obligations.
To meet general legal or regulatory obligations.	Our Legal and Regulatory obligations.
Statistical analysis.	Our legitimate interests – to refine and enhance the products and pricing which we can offer.

# Marketing

We may contact you by email, telephone, mail or other agreed means to keep you up to date about our products and services. The legislation allows us to do this in our own commercial interests for certain communications with previous customers. In other circumstances we can only do so with your explicit consent. In all cases you can opt out from receiving such communications at any time.

### **Disclosure of your Personal Information**

As a necessary part of providing you with the services described above we may need to disclose your personal data to other third parties. These include your selected fund managers, the Cofunds or FundsNetwork platforms, Regulatory authorities and the Police or other law enforcement bodies that assist with fraud prevention and detection. We may share information with other third part providers that assist this firm with the internal roles including our accountants, compliance support and IT specialists.

### **Retention Period**

Your data will not be retained for longer than is necessary and will be managed in accordance with our data retention policy. In most cases the period will be for a maximum of 7 years following the disinvestment and closure of your account with this firm. We may be required to retain the data for a longer period due to business, legal or regulatory requirements.

#### International transfers of data

We do not presently transfer your personal data to destinations outside the European Economic Area (EEA). Should this become necessary in the future we will ensure that it is treated securely and in accordance with the legislation.

### Your Rights

Under the legislation you have the following rights in relation to our processing of your personal data: -

1. The right to be informed about how we use your personal data (This Privacy Notice);

2. The right to see a copy of the personal information we hold about you. (In most cases this will be free of charge);

3. The right to have personal information rectified if inaccurate or incomplete:

4. The right of erasure of your personal information where there is no compelling reason for its continued processing;

5. The right to restrict processing in certain circumstances, e.g. if its accuracy is being contested;

 The right to data portability which, subject to certain conditions, allows you to obtain and reuse your personal data across different services;

7. The right to object to certain processing including for the purposes of direct marketing;

8. Rights to information in relation to automated decision making and profiling.
